13 DESCRIPTION OF COMPONENT

The Ring Coupling Module (RCM) handles the communication between the I/O modules and the Control Centre Board (CCB) in the Touchpoint Pro (TPPR) system, which detects gas and fire in gas installations. The RCM contains a Ring Coupling Board enclosed in a plastic housing. It is intended to be mounted on a DIN rail inside a cabinet that provides an ingress protection of at least IP54.

The RCM is powered through the backplane edge connector on the Ring Coupling Board (RCB). The connections for the internal Ring network are provided through the backplane edge connector and the external ring network is connected at the field terminals on the module.

External power connections are made to the rear of Ring Coupling Board edge connector, which plugs into a Backplane mounted on a DIN rail.

Rated voltage at the DIN-rail edge connector = 18V-32V dc
